



## MEMORADUM OF UNDERSTANDING

between  
ARIEL UNIVERSITY  
(Ariel, Israel)

and

State Higher Educational Establishment "Donbas State Pedagogical University" (Sloviansk, Ukraine)

In accordance with a mutual desire to promote activities between Ariel University and State Higher Educational Establishment "Donbas State Pedagogical University", the two institutions (organizations) agree to the following statement of intent on cultural, educational and research cooperation.

Cooperation and development of activities may extend to any fields and subjects in which the two institutions (organizations) may identify shared interests. The initial area of cooperation is research cooperation.

The two universities agree to cooperate in the following general areas:

1. An exchange of scholars and scientists to conduct research of mutual interest
2. An exchange of faculty for lectures and short term visits
3. Invitations to scientists to participate in conferences and symposia
4. An exchange of information, academic materials and publications in fields of mutual interest.

Both parties agree that all financial arrangements necessary to implement this General Agreement or any subsequent agreements must be negotiated according to the regulations of each institution and will be dependent upon the availability of funds. Both parties recognize that this General Agreement establishes a foundation of mutual understanding and interest, and does not in itself entail any financial obligations to either organization.

Each university will appoint a liaison officer who will be responsible for the coordination and the administration of collaboration/exchange programs. Each liaison officer will be responsible for providing his/her counterpart with information about the academic background, record and interests of proposed participants in the exchange. It is understood that both institutions will nominate only individuals of the highest scholastic standing and potential.

This agreement for partnership, cooperation and scientific exchange shall remain in effect for a period of five (5) years from the date of the last signature, with the understanding that it may be terminated by either party given three (3) months written notice to the partner university.

This agreement may be amended with the consent of both universities through a written addendum executed by authorized individuals from both universities.

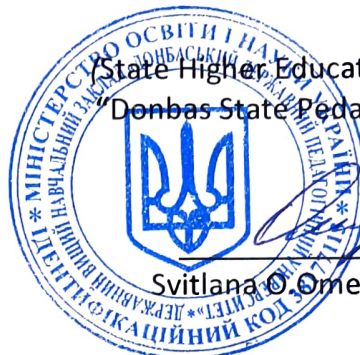
